IMPORTING AND EXPORTING non-CITES HERBARIUM SPECIMENS

FOR IMPORTING TO THE U.S.A.

If the specimens being sent are not on the CITES list of endangered plants, then sending them into the U.S. should still be fairly straightforward. CITES shipments require a few more steps and both sending and receiving institutions must be CITES registered or obtain CITES Permits before shipping.

The sending institution will need to include the following information on the Customs Declaration:

1. The HS code for the shipment, minimum six digits (herbarium specimens fall under the HS Code: **9705.29.00** = Collections of zoological, botanical, mineralogical, archeological, paleontological, interest. If they are CITES plants, then the HS Code is 9705.22.00)
2. A full description of the goods, i.e.:
 - o What is it? (Preserved [zoological, botanical, mineralogical, anatomical, paleontological, archaeological, ethnographic, historical specimens/museum objects)
 - o What is it made of? (e.g. ethanol preserved invertebrates, fish, dry insects/herbarium specimens, mineralogical specimens, etc.)
 - o What is it intended for? (Scientific research, followed by a more detail description like biodiversity/taxonomic/molecular/mineralogical/paleontological research)

We have used the following as a Description of Goods: **Preserved, pressed and dried herbarium specimens without capability of propagation for scientific research (biodiversity research and taxonomy), no commercial value as well as, Dead and dried botanical specimens for scientific research only, no commercial value, not for resale – not restricted**

3. The declared value of the samples (not more than 1 US Dollar/Euro unless the specimens were acquired as purchase and have a commercial invoice with the actual value of the material). We usually go with a value of \$ 1.00 per box (not per specimen).
4. The correct country of origin (i.e. the home country of the shipping institution, NOT the country where the material was collected)

If you plan to send the specimens using a private courier like DHL, UPS, or FedEx, then they will have additional paperwork that needs to be filled out and is usually provided by them.

FOR EXPORTING TO OTHER COUNTRIES

The instructions are basically the same as above with the addition of the EORI and CPNJ numbers.

5. Add the Economic Operators Registration and Identification (EORI) number for boxes sent to European Union and United Kingdom Countries and the Cadastro Nacional de Pessoas Jurídicas (CNPJ) number for boxes sent to Brazil. We also like to add this number to the address labels.

Some countries have more specific rules and regulations, so these are listed separately below:

INFORMATION ABOUT SENDING non-CITES HERBARIUM SPECIMENS TO SPECIFIC COUNTRIES

Argentina	An Import Permit may need to be obtained before the box can be sent. Contact the herbarium before sending anything.
Australia	Contact the herbarium before sending anything so they can give you their most up to date Biosecurity guidelines and permits.
Bolivia	If sending via USPS, Priority Mail International is not available but can be sent as Express, which is more expensive. First Class is also available for boxes under 4 pounds.
Brazil	Send them your tracking number(s) in advance so that they can contact the Brazilian Customs authorities about the shipment. Also, include their CPNJ number on the Customs Declaration and address label.
Colombia	An Import Permit needs to be obtained before the box can be sent. Contact the herbarium before sending anything.
Cuba	We don't send any shipments to Cuba.
Ecuador	They require a Phytosanitary Certificate, so we do not send shipments.
Japan	We don't usually send too many boxes here but in 2023, specimen shipments had to be sent to a Plant Protection Station first. Contact the herbarium before sending anything.
New Caledonia	An Import Permit needs to be obtained before the box can be sent. Contact the herbarium before sending anything.
New Zealand	Contact the herbarium before sending anything so they can give you their most up to date Biosecurity guidelines and permits.
Russia	They require a Phytosanitary Certificate, so we do not send shipments. It is also illegal to send plants.
Spain	They have issues with customs, so we are adding this sticker to the boxes: la mercancia son ejemplares botanicos para uso cientifico, sin valor comercial. TARIC 97052900
Venezuela	Due to the past economic issues within this country, we haven't sent any shipments to Venezuela. Contact the herbarium before sending anything.
Countries in the E.U. & the U.K.	The EORI number of the institution receiving your shipment should be included on the Customs Declaration and address label. If unknown, contact that herbarium to get it.

When in doubt, always email the herbarium prior to sending any shipments to get the most up to date information about shipping regulations. It seems like the rules are always changing.

ESSENTIAL THAT YOU TAKE INTO ACCOUNT THE FOLLOWING:

Customs are becoming increasingly restrictive and demanding of shipments from outside the EU. From our experience over the last few months, three things are essential to avoid problems, delays and costs when dealing with customs clearance.

1. Avoid sending through courier companies. If the package arrives in this way, it will almost certainly be retained, the procedures for its recovery are very complex and our institution cannot carry them out, we do not have the authorized personnel to do so. As an alternative, use the national postal service of your country, in the most convenient and secure way (registered, with tracking, etc.). In this way the package will reach the Spanish postal service and in this case we will be able to process the delivery.
2. Attach a detailed and precise declaration of the contents, avoiding certain words or expressions, but obviously without misrepresenting the truth. Also include the corresponding harmonized code (HS code). Never write "plants", "mushrooms" or other generic expressions, as they can be misinterpreted, and the package will be referred to an additional inspection.

The most appropriate expression, and not untrue, and the corresponding HS code are as follows: "COLLECTIONS AND SPECIMENS FOR BOTANICAL COLLECTIONS [HS Code 970529], DRY AND DISINFECTED, FOR SCIENTIFIC RESEARCH ONLY, OF NO COMMERCIAL VALUE", which fits into a well-defined and pre-established category (HS code **970529**).

3. Since March 2023 it is mandatory for shipments to the EU to complete the recipient's data with the corresponding EORI (customs identifications number of the Recipient in the EU). Ours is "EORI: **ESQ2818018J**" and it must be added to our data as addressee/recipient in the documentation and labels of the parcel:

Important information:

- If you send specimens by a private postal company, it is critical that you mention that our office is only open from Monday to Friday, 8:30 a.m. to 4:00 p.m. Otherwise, the Museum will not be able to receive the package.
- In the customs declaration, the contents should be described as "Dead, dried Herbarium specimens for scientific studies only. No commercial value".
- If you must declare a value for the package content, please add a low commercial value (3-5 euros); otherwise, we might have to pay an expensive tax and if the package could not be received directly in our office, it slows down the delivery process.
 - Please mention to the outside of the package the 4 identification numbers for customs declaration:
 - Siret Identification number (for MNHN): 180 044 174 000 19
 - Intra Community VAT number (for MNHN): FR 62 180 044 174
 - HS Tariff number (herbarium specimens for scientific studies): 9705.00
 - EORI number (only for importing herbarium materials from outside EU countries): FR18004417400019
- As much as possible, please send an email to herbier@mnhn.fr with the tracking number so that we can follow the package transport carefully.

HOW NY BUNDLES LOAN SHEETS FOR SHIPMENT:

Whenever we ship loans, we place each sheet either in its own paper folder (e.g. our type specimens) or every other sheet in its own paper folder. If there are any parts that stick up or are bulky, we will put a piece of foam or bubble wrap on top of that sheet. Then we stack the sheets on top of each other and then put them in between 2 pieces of cardboard and tie them up widthwise with 2 pieces of string to get a bundle that is snug but not too tight. We try to keep our bundles between 3-4 inches in height. Then we wrap each one up in newspaper and tape as if it were a birthday gift. The bundles are then placed into a cardboard box and should also be snug but not too tight. You can fill empty spaces with [more](#) bubble wrap, packing peanuts, or other suitable materials.

HOW NY HANDLES OUTGOING SHIPMENTS THAT FALL UNDER THE NAGOYA PROTOCOL:

Nagoya Protocol information for the Herbarium Shipping Office:

The United States has not yet signed The Nagoya Protocol, but NY is doing our best to follow the rules whenever we send shipments internationally. Before sending out **Gifts**, **GFD**, and/or **Exchange** specimens to an **international Herbarium**, we check every specimen to see when it was collected. If they were collected before 1 October 2014, then they can be sent out with just a Material Transfer Agreement (MTA) form. But if they were collected on or after 1 October 2014 then they are subject to The Nagoya Protocol.

For the specimens collected on or after 1 October 2014, we will have to check if the destination is to a country that has signed the Nagoya Protocol. If not, then we can send the specimens with an MTA only. If they have signed it, then we will need to know all the collector and collector numbers for every specimen being sent and provide the MTA along with the documents and permits showing that the plants were collected legally and with permission. Physical copies should be sent with the specimens and electronic versions should be e-mailed to the herbarium.
